On a motion by Dr. Goellnicht, seconded by Ms. Wagner, the committee approved the minutes of the meeting of February 2, 2010.

Business arising

Dr. Head recalled that at the last meeting, the committee did not approve the proposal to remove the GRE/GMAT admission requirement for the Master of Communications Management. At that meeting, the committee suggested adding a specific admission requirement for applicants who do not possess a four-year degree. To address the suggestion of the committee, Dr. Head explained that the program is now proposing to require a GMAT or GRE for applicants who do not hold a university degree.

Dr. Hassanein moved, and Dr. McCracken seconded,

"that the Faculty of Business Graduate Curriculum and Policy Committee approve that anyone with a university degree (meeting the minimum requirements) would not have to complete the GMAT or GRE for consideration to the Master of Communications Management program. A GMAT or GRE would be required for any applicants who do not hold a university degree."

The motion was carried.

Global Health

Dr. Archer briefly discussed the proposed calendar copy for the M.Sc. program in Global Health.

Dr. Hassanein moved, and Dr. McCracken seconded,

"that the Faculty of Business Graduate Curriculum and Policy Committee approve the proposed calendar copy for the M.Sc. program in Global Health, as described in the document."

The motion was **carried**.

Dr. Archer then presented the four new courses for the M.Sc. program in Global Health:

- *702 Global Health Foundations II

- 711 Scholarly Paper

Dr. McCracken moved, and Dr. Hassanein seconded,

"that the Faculty of Business Graduate Curriculum and Policy Committee approve the new courses, *701, *702, *710, and 711, for the M.Sc. program in Global Health, as described in the documents."

The motion was carried.

eHealth

Dr. Archer presented a minor change to the M.Sc. program in eHealth calendar copy. The proposal is to add a statement specifying that an undergraduate course in statistics would be advantageous for applicants in the program.
