# **Program Information**

#### Overview

The Master of Public Policy in Digital Society is a professional graduate degree program that offers an innovative curriculum which seeks to bridge public policy thinking with technical expertise. The program trains prospective policy leaders to navigate the rapidly changing dynamics of the technological landscape to more effectively address the complex social, political, and economic challenges that have accompanied the digital age.

The MPP in Digital Society employs an innovative approach to learning which involves a mix of formats including traditional seminar-style courses, skills development labs, and professional development workshops. Collectively these formats allow for self-directed, team-based, experiential learning opportunities that address real-world problems and which draw on McMaster's signature problem-based learning approach.

The program welcomes applicants who have completed an undergraduate degree in fields such as political science, economics, sociology, communication studies, public policy, public administration, judicial studies, psychology, computer science, engineering, information science or related disciplines.

# **Duration of Study**

The Master of Public Policy in Digital Society is a full-time program which runs from May to April.

# Degree Requirements

The MPP in Digital society is a coursework-based program. Students will complete three semesters across 12 continuous months. Each semester is a four-month term consisting of three 3-unit seminar courses and three 1.5 unit skills development labs for a total course load of 13.5 units per semester. All seminars and skills development labs are required for graduation from the program. No electives are offered.

# Protocol for Instructor being late to Zoom

If a Zoom class has not started within 15 minutes of the class time and there has been no correspondence from the instructor via email or A2L, students can leave class and assume that there is an extenuating circumstance that warrants a make-up class. A student can email the Instructor and CC the Academic Director and Executive Director regarding the cancellation of class.

# Tuition & Supplementary Fees

The tuition fees for Canadians/Permanent Residency in the MPP-DS program is \$9,700/term. There are three terms, therefore total tuition is \$29,100.

International Tuition is \$18,500/term. There are three terms, therefore total tuition is \$55,500.

Supplementary Fee Change Effective Fall 2022:

We wanted to give you some information related to your supplementary fee charges.

Given the online nature of the program, we were able to negotiate some supplementary student fees that mirror the payment obligations of part-time students; namely the Student Athletics and Recreation fee as well as the Student Wellness Centre fee. All others are charged at the full time rate, with the caveat that you may be eligible to opt-out of the following fees:

- Health and Dental charges through the GSA: the cost of coverage for GSA members is \$459.00.
   Here is information on opt-outs and how to opt out. The Change-of-Coverage period for these charges is from September 6th-October 3<sup>rd</sup>, 2023.
- 2. <u>HSR Bus Pass</u> through the GSA: Laura will email the criteria and instructions regarding the bus pass opt-out to all students during the summer you enter the program. You need to signal that you meet the criteria to opt-out and wish to opt-out on or before October 31<sup>st</sup>. If the nature of the program changes in the future (ie. more in-person components), the fee structure will be re-evaluated at that time.

#### Financial Aid

Please note that the MPP program is eligible for student loans under the Ontario Student Assistance Program (OSAP).

We can provide some general OSAP information, with the caveat that every student's OSAP assessment is different and can be subject to change.

When a student receives OSAP, their assessment is based on a variety of factors, such as:

- The cost of their program
- Their percentage of course load that they are enrolled in
- Their status (single dependent, single independent, married, common-law (with or without children), or sole-support parent
- If a student is single, whether or not they reside with their parents during their study period
- Any assets
- Their income from the previous taxation year
- Their parents' or spouse's income from the previous taxation year (if applicable)
- Any study period income (including scholarships, bursaries, awards, employment income, spousal and/or child support, etc.)
- Overall family size

If a student experiences any changes during their study period (i.e., adding or dropping courses, making more or less income, etc.), they need to submit the change in writing. The Registrar's Office at McMaster will then process the change(s) and this can affect a student's assessment. Sometimes, the student may have been assessed for too much OSAP and they incur what is called an overpayment.

If an overpayment is below a certain threshold, the student doesn't need to pay it back at that time. However, overpayments may cause some grants to convert to loans, which the student will need to eventually repay once they have stopped being a full-time student for 6 months. If an overpayment is very large and over a certain threshold, then the student may be restricted from receiving future OSAP until they pay off a certain amount of the overpayment. If any of these scenarios happen, then the student will receive a communication advising them of that.

If you have questions about the OSAP and/or have any changes, please speak with a <u>Student Services</u> <u>Professional in the Student Services Office</u>. The SSPs can advise students of how changes will affect their OSAP and let them know any actions that they need to take.

#### Internal Scholarships

Any student to whom we offer admission is automatically considered for financial assistance in the form of a graduate scholarship. No special forms need to be filled out. Funding is awarded on academic excellence and the availability of funds. Funding is open to all domestic and international students. The amount of graduate scholarship funding listed in your offer is the total amount you will receive over the course of the program (one year). Graduate scholarships are paid out at the <u>beginning of each term in equal instalments</u>.

In addition to graduate scholarships, students are encouraged to use McMaster's platform <u>"Award Spring"</u> which matches students with available relevant funding opportunities. Award Spring is only accessible to current students; incoming students may not have access until August.

Master of Public Policy Needs-Based Funding

Additional financial support is available to you on the basis of demonstrated financial need. To be eligible for this funding, you must be a registered student (see above instructions), and you must complete a separate application via McMaster University's online aid and awards platform, <a href="AwardSpring">AwardSpring</a>. You can complete one common application that matches you with all the aid & award opportunities you're eligible for. Ours is <a href="Master of Public Policy Needs-Based Funding">Master of Public Policy Needs-Based Funding</a>. The application opens <a href="August 10">August 10</a>, <a href="2024">2024</a> and closes <a href="September 30">September 30</a>, <a href="2024">2024</a>. Submitting an application is not a guarantee of further financial support, but you are strongly encouraged to apply.

**NOTE**: Graduate students must be active students and enrolled in studies to be able to apply for awards in AwardSpring.

McMaster Scholarships and Bursaries

MPP graduate students who demonstrate financial need can apply for the McMaster Graduate General Bursary.

Please note: The McMaster Graduate General Bursary Program is not open to international students enrolled in graduate studies, MBA, medicine or physician assistant programs.

Students in the MPP are also eligible for the Rainbow Fund. By demonstrating financial need and applying to the General Bursary, students will automatically be considered for certain bursaries like the Rainbow Fund Bursary (to be considered for the Rainbow Fund Bursary the student must also self-identify as 2SLGBTQIA+ in the main <a href="mailto:AwardSpring">AwardSpring</a> application).

If you wish to apply, you will be asked to submit financial information and documents through <u>AwardSpring</u>. That information will be assessed by the Office of the Registrar to confirm if the student demonstrates financial need. If it is determined they have financial need, a financial need score will be assigned.

The General Bursary application opens mid-August and closes mid-January. Funding is paid out in mid-February. MPP-DS students need to fill out a form that mimics the questions OSAP asks. It is recommended to complete this form well before the deadline to allow time for review by Financial Aid staff. The Office of the Registrar will then provide SGS relevant information concerning students with a financial need score so SGS can determine if the student qualifies for the General Bursary.

Wilson Leadership Scholar Award (WLSA)

We also refer students to the <u>Wilson Leadership Scholar Award</u>. There are up to a total of 10 awards available each year, valued at \$12,000 in direct funding and up to \$2,000 in experiential funding. Each cohort will include both undergraduate and graduate students.

#### TA/RA Work

Teaching and Research Assistantships are not guaranteed for MPP students, but positions are possible and will be circulated by email to students as they become available.

#### Student Work Program

The McMaster Work Program allows graduate students who demonstrate financial need opportunities to work on campus part-time (max 10 hours/week) during the fall/winter terms.

Students can apply via <u>AwardSpring</u>, and applicants will be required to demonstrate financial need through an assessment that is similar to OSAP's.

A grounding in digital technology and public policy is an asset for a much broader range of public sector employment opportunities.

The demand for public policy experts with a specialization in digital technology is by no means exclusive to the public sector. Many tech companies are incorporating a policy function into their organization.

#### Student Card

Photo requirements: To be accepted as your student ID photo, your upload must:

- Be recent and similar to a passport photo (headshot only, looking straight into the camera)
- Have a neutral or non-smiling expression
- Be in colour, focus, good quality (i.e. Scanned photos of your drivers licence, passport or health card are NOT acceptable)
- Be on an uncluttered background and of you alone (no other people, animals, etc permitted in the photo).
- Must <u>not</u> contain any props (no hats, sunglasses, or graduation caps)
- Maximum photo size must be 3MB or less to be successfully uploaded.

Uploaded photos not meeting the above criteria will be deleted, resulting in delays in receiving your student card. Also ensure your personal information is up to date – especially your mailing address – in your student profile.

The Registrar's Office will mail MPP students their card to the mailing address provided in your Student Centre. Please ensure your mailing address is added/up to date.

#### Procedure for failing grades

We have some guidance from SGS on the risk of failure of a course for a student and implications for their ability to continue in the program.

Each course is especially important as it is required to move onto the next term. We have been advised that in cohort models, a student can often take on some extra work to remediate and stay in the cohort OR if that is not possible, they could request to take a leave of absence or withdraw from the program in good standing and return in a future cohort.

\*The <u>General Regulations of the Graduate School</u> [policy] indicates that students can be withdrawn after one failure.

# MPP Program Policies

#### Attendance Policy

The MPP is a synchronous virtual program. To benefit from the class teachings and discussions, which all happen live, it is necessary to be present and to participate. Consequently, attendance in class is mandatory unless there is a good reason for a student to be absent, such as illness. It is the student's responsibility to notify instructors regarding any absence, and to provide the reason for that absence. While many classes include a participation component in the grade, the program discourages participation grades for simply being present, in keeping with our policy that attendance is a baseline, mandatory expectation.

#### Bereavement Leave Policy for Students

If a student experiences the death of a loved one during the course of an academic term, the student may request to utilize the Bereavement Policy for Students. We recognize the impact that a loss may have on the emotional and academic well-being of a student and wishes to support the student during this stressful time. We also understand that grief impacts every student differently and, therefore, this policy is not an attempt to quantify the impact of the death of a loved one or in any way address the nature of the grief process. Rather, the purpose of this policy is to provide a formal process to allow grieving students the time to attend the bereavement services, as well as the opportunity to be available for their families during times of death and grief.

Under this policy, a student will be excused from class for funeral leave, subsequent bereavement, and/or travel considerations. A student is entitled up to five (5) consecutive *academic* days of bereavement to mourn a death in the immediate family as defined below. For a death outside the immediate family as defined below, a student is entitled up to two (2) consecutive *academic* days of bereavement. While this policy excuses a student from class attendance, the student remains responsible for all material covered in class and must work with each individual professor upon return to complete any required work.

The immediate family includes:

- Parent(s) or legal guardian(s)
- Siblings
- Spouse or partner
- Children
- Other relatives living as members of the student's household

Relationships outside the immediate family may include, but are not limited to:

- Grandparents
- Aunts or uncles
- Cousins
- Nieces or nephews
- In-laws

**Disclaimer**. The Program reserves the right to review specific situations to determine if exceptions to the established bereavement policy are warranted.

#### Scope of Applicability

This policy is applicable to all full-time Master of Public Policy Graduate Students.

The MPP mandates appearance on camera during all synchronous sessions. Accommodations may be made on a case-by-case basis with the course instructor(s).

#### **Travel Days**

In addition to the aforementioned excused academic days, students may be granted up to three (3) additional calendar days to account for travel considerations.

#### **Process and Notification**

The student or a representative (family member, room/suitemate, on-campus faculty/staff) must notify the MPP Program Office at <a href="mailto:pubpol@mcmaster.ca">pubpol@mcmaster.ca</a> <a href="prior">prior</a> to the start of the bereavement leave. The Coordinator will notify the MPP Program Directors and relevant course instructors of a student's bereavement leave and anticipated return date. The student is required to provide appropriate documentation to the MPP Office. Upon return to the institution, it is the responsibility of the student to communicate with their instructors about any missed assignments and arrange to complete missed work. In keeping with this policy, instructors shall excuse the student from class according to this policy and provide an opportunity for the student to complete missed quizzes, exams, papers, other required work and/or alternative assignments. Students who have followed this policy should not incur academic penalties.

#### **Documentation**

Any student who wishes to utilize this policy is required to provide documentation to the MPP Program Coordinator at <a href="mailto:pubpol@mcmaster.ca">pubpol@mcmaster.ca</a>. Acceptable documents may include: a funeral program, obituary, signed letter from funeral home, or death certificate. Failure to provide documentation will result in the absences being considered unexcused.

#### **Appeal**

If an instructor fails to follow this policy, the student may appeal the instructor's decision in writing to MPP Program Academic Director.

#### **Counselling Services**

#### Camera Policy

Good graduate education is interactive and participatory; generative discussions require active presence, and in an online program, that means being on-camera. Your learning experience, and the experience of your classmates, will be better if you are visibly taking part in the class. Not only does appearing on camera enhance the classroom dynamic but it also offers an opportunity to develop more substantive relationships with your instructors which is also to your benefit, as when your instructor is asked to provide you with an employment reference they will know you better. The MPP Program appreciates that it is exhausting to have to appear on camera for every synchronous session. There are some ways to mitigate this using <u>strategies to mitigate Zoom fatigue</u>, including <u>hiding your self-view</u> and <u>changing</u> or <u>blurring</u> your background if you wish. However, as you move forward professionally you will be expected to appear on camera at least as often as you are being asked to do in this program. Appearing on camera during meetings when working remotely is a standard in most professional settings and acquiring the capacity to manage those expectations is an important professional skill.

#### Sexual or Gender-Based Violence Policy

All members of the MPP Program have a right to study, work, and live in an environment that is free of any form of sexual or gender-based violence. Please know the program will take the matter seriously and help to connect you to any support you may require.
