I. Opening Remarks

Dr. Hranilovic reported on the following items:

- Provincial Attestation Letters (PALs) for international student and the effect on graduate recruitment;
- Curriculum changes, highlighting the graduate diploma and microcredential coming for approval.

II. Minutes of the meeting of September 17th, 2024

It was duly moved and seconded, **‘that the Graduate Council approve the minutes of the September 17th, 2024 meeting, as circulated.’**

The motion was **carried**.

III. Business arising

There was no business arising.

IV. Report from the Associate Deans, Graduate Studies

Dr. Grandfield (Faculty of Engineering) reported on the following item:

- Upcoming curriculum changes.

Dr. Hanna (Faculty of Health Sciences) reported on the following items:

- Work on publishing the names of all eligible supervisors and to streamline the process for approval within the Faculty;
- The development of a new policy regarding stacking credentials, noting it will come to Graduate Council for approval.

Dr. Heathorn (Faculty of Humanities) reported on the following item:

- The introduction of new graduate student representatives, Marissa Cino and Kalla Graham

Drs. Heath and Newbold had no report.

V. Report from the Associate Registrar and Graduate Secretary

Ms. Baschiera reported on the following items:

- Submission of questions to the IRCC around PALs and related admissions work;
- The upcoming supervisory committee report deadline, noting scholarship implications if reports are not submitted on time;
- A pilot project with the Student Success Centre (SSC), regarding the front desk of the School of Graduate Studies.

VI. Report from Certificates, Diplomas and Microcredentials Committee

a. Graduate Diploma in Global Surgery: Surgical Care Systems & Health Equity

Dr. Hranilovic explained the context of the joint Certificates, Diplomas and Microcredentials Committee and the report with two items for consideration stemming from it.

Dr. Hanna noted that the proposed diploma had been approved through the Faculty committees, had been to Certificates and Diplomas and University Student Fees Committee. It comes to Graduate Council ahead of University Planning Committee and Senate.

Dr. Chen presented the diploma, providing the context and need for access to safe surgical care. The diploma will be focused on surgical care systems and right now there are no options in Ontario for graduate work in this area. The proposal is for a standalone graduate diploma which would be online, asynchronous, and offered by Global Health program with four 3-unit courses.

Members discussed fees for students and learners from low- and high-income countries. Dr. Hanna highlighted that fees discussions are to be addressed at University Student Fees Committee but that all students enrolled in the program would be charged the same fee and if there was to be additional support there would have to be revenues from the program or another area.

Members discussed the qualifications for students and Dr. Chen highlighted the diversity of professionals that are required for global surgical systems.

Dr. Hranilovic provided some additional context for the approval process, noting UPC's role in reviewing both the academic and resources considerations.

It was duly moved and seconded, **'that the Graduate Council approve, for recommendation to the University Planning Committee and the Senate, the Graduate Diploma in Global Surgery: Surgical Care Systems & Health Equity, as circulated.'**

The motion was **carried**.

b. Non-Academic Microcredentials in Health Technology Assessment

Dr. Feng Xie presented the microcredentials noting that a new technology or medical device needs to receive approval that it's safe to use and highlighted the context in publicly funded healthcare systems. They will be targeted to working professionals.

In response to a question Dr. Xie confirmed that the courses are new.

It was duly moved and seconded, **'that the Graduate Council approve, for recommendation to the University Planning Committee and the Senate, the following non-academic microcredentials in Health Technology Assessments, as circulated.'**

The motion was **carried**.

VII. Fall 2024 Graduands

It was duly moved and seconded, **'that Graduate Council approve the list of the 2024 Fall Graduands, with amendments/corrections to be made as necessary by the Associate Graduate Registrar.'**

The motion was **carried**.

VIII. New Awards and Changes to Award Terms

It was duly moved and seconded, **'that Graduate Council approve the new award with terms as circulated.'**

The motion was **carried**.

IX. Provisional Guidelines for the Use of Generative Artificial Intelligence in Research

Dr. Erin Aspenlieder presented the guidelines, highlighting McMaster's AI Advisory Committee with three expert panels.

She noted that the draft circulated was developed with the panel on Research and has received feedback from a number of areas while noting that they were still seeking feedback from faculty and students to ensure that it's useful for campus needs.

The guidelines are intended to address graduate students as researchers during their dissertation research. Students concerned with coursework should be looking at the Teaching and Learning Framework.

Dr. Aspenlieder highlighted that the guidelines are not a policy, noting both the variability in campus approach and the rapidly changing technology.

Members discussed the role of the supervisor in approving a student's use of AI, tools being developed to support usage on campus, concerns around the usage of the tool (including privacy), examples of where it can be used, intersections with existing policies (including the Academic Integrity Policy), and ways to make students aware of the requirements.

Dr. Aspenlieder highlighted a link for feedback and Dr. Hranilovic noted that Dr. Aspenlieder had been involved in the development of a guide adopted by the COU. Both would be circulated to members.

Members discussed the incoming requirement for PALs and the deposit fee, noting concerns about students having to pay up front and the difference in undergraduate versus graduate recruitment. Dr. Hranilovic noted that the change they're putting forward would allow the possibility for Faculties to charge a deposit fee if they would like to, highlighting the potential for a student to take a PAL to another institution.

Members discussed the PAL usage sectorwide.

Describe the existing requirement/procedure: Our calendar says the following:

Admission

The minimum standard for admission to the Ph.D. program is a **Master's degree** from a recognized university, with a B+ average. Admission is competitive: not all applicants who meet the minimum standard will be offered admission.

Provide a detailed description of the Recommended Change (*Attach additional pages if space is not sufficient.*)

We would like to modify the requirement of holding a masters' degree to allow direct entry of exceptional undergraduates into the Phd program. The new language would be as follows.

Admission

The typical minimum standard for admission to the Ph.D. program is a Master's degree from a recognized university, with a B+ average; however, excellent candidates may be considered with an undergraduate degree in Economics or subjects with high levels of mathematical training. Admission is competitive: not all applicants who meet the minimum standard will be offered admission.

Rationale for the Recommended Change (How does the requirement fit into the department's program and/or tie to existing Program Learning Outcomes from the program's IQAP cyclical review?):

A number of competing schools in Canada such as Western and McGill are moving to allow undergraduates to move directly to PhD and we would not want to lose the best students who might otherwise prefer to go to the US where direct admission is typical, or to the above-mentioned Canadian schools in order to save a year.

We note that at McMaster, several departments already allow direct entry into their PhD, for example Chemistry, Engineering Physics and Computer Science. Finally, we note that the best MA Econ students already take the same courses as first year PhD students and then directly get admission into the second year of the PhD program. Our change then amounts to bringing clarity and structure to an existing practice of some students saving a year in their academic journey.

Ideally, we would like to start with this admission cycle so that such students can enter in the 2025-26 academic year.

Candidates for the M.A. in Economic Policy must complete eight half-courses. The following five half-courses are required for all candidates:

ECON 727 / Microeconomic Theory for Public Policy

ECON 728 / Macroeconomic Theory for Public Policy

ECON 761 / Econometrics I

ECON 773 / Economic Policy Analysis I

ECON 774 / Economic Policy Analysis II

Additional Information

ECON 761 may be waived if equivalent work has already been completed by the student in undergraduate course work. A student's claim to have completed equivalent work will be tested by examination at the beginning of the academic year. Students who have previously taken 4g03 or equivalent must take 761. Students who wish to take 761 who have not taken 4g03 or equivalent will take a pass/fail exam prior to entering 761. If they do not pass the exam they must take 6G03.

We would like to make two clarifying changes.

1. While the calendar refers to two possible econometrics courses (761 and 6G03), it does not clarify that the program will decide which one of the two must be taken. This streaming has been part of the program for years, but I noted this lack of clarity this year.
2. We would like to introduce more clarity around the three elective options available to MAEP students, building on language used in the MA Economics description.

Rationale for the Recommended Change (How does the requirement fit into the department's program and/or tie to existing Program Learning Outcomes from the program's IQAP cyclical review?):

This past year a number of MAEP students were confused about what courses they could take and I tracked down the problem to the calendar which is less precise than our departmental page.

Describe the existing requirement/procedure:

To date, students have had to complete all of the offered courses in order to complete the degree, including PUBPOL 701, 704 and 705. Remedial decisions for students who failed any of the seminar or skills labs courses have been ad-hoc. Occasionally, students have had the opportunity to submit an assignment late, or 'make up' a final assignment through resubmission. In the interim, an INC grade was granted. In some instances, students returned the following year to re-take a course in its entirety (e.g. PUBPOL 705 – Policy Capstone).

Provide a detailed description of the Recommended Change (*Attach additional pages if space is not sufficient.*)

The recommended change includes two components:

First, we have designated three core courses that students must complete in order to earn the degree and for which we will not offer remediation. Those courses include PUBPOL 701 as the first and foundational course in the program and for which students must successfully complete or they will not have sufficient foundations to proceed through the program. The other two courses, PUBPOL 704 and 705, are also important demonstrations of the key concepts and ideas of the program, but can be completed at a later date (retaken) if initially unsuccessful.

Second, we are concurrently creating two Special Topics courses (one is 3-units and the other is 1.5 units) as an option for the remediation for the remainder of the courses offered in the program. In the past, we have used a Special Topics course to supplement the course credit for a graduate seminar that was failed by a student (with extenuating circumstances). We want to reserve this option to preserve flexibility.

Rationale for the Recommended Change (How does the requirement fit into the department's program and/or tie to existing Program Learning Outcomes from the program's IQAP cyclical review?):

This is unrelated to review. Rather, as the program has matured, we see an opportunity to clarify whether and when remediation pathways are available to students upon their failure

in a class. This will assist Professors and Instructors with their planning. It will also clarify for students where they will have to re-take a course or may have the option to submit supplemental work, or whether failure results in their termination as a student (PUBPOL 701).

- We have looked at other programs (physiotherapy) for guidance.

For us, ideally it would be spring 2025, which coincides with the start of our next scholastic year (we fall outside of the traditional academic year). We can update the student calendar and course syllabi (as well as relevant sessional posting) accordingly.

Are there any other details of the recommended change that the curriculum and policy committee should be aware of? If yes, please explain:

Worth noting: We currently offer students the ability to petition for a waiver based on existing competencies, but have only ever granted a waiver for the Project Management Skills Lab (PUBPOL 756). In these instances, the student held the Project Management Professional (PMP) certification. We are able to work with SGS to amend the number of required units for graduation when/if this has been the case.


I am writing to express support for the expansion of the housing curriculum at McMaster University. We have been informed that McMaster University is considering developing new programs on housing, and it is my opinion that such an initiative would be beneficial to the housing data, research, and policy community.

Since the Budget 2017 investments in housing data and research, meaningful improvements have taken place in terms of the production, dissemination, and analysis of housing data. Those investments have allowed Statistics Canada and the Canada Mortgage and Housing Corporation to develop new sources such as the Canadian Housing Survey and the Social and Affordable Housing Rental Market survey. They have also supported the creation of important research hubs such as the one you lead and the Housing Research Collaborative at the University of British Columbia. There however remains important gaps in terms of post-graduate training on housing. As a result, agencies like Statistics Canada must train new graduates on the housing subject matter since few universities provide curricula on the topic. We have also witnessed relatively low uptake of housing microdata in the post-graduate community, potentially as a result of a skills and training gap.

I thus encourage McMaster University to consider opportunities to improve the training of the next generation of housing practitioners, to allow for an integrated vision of economic, social and environmental domains through a housing lens. The traditional approaches to training – that is seeing housing as a part of other domains such as the macroeconomy, health or social sciences, rather than a focus of its own – do not provide the tools necessary for today's housing challenges.

I would also like to thank you for the input and support that McMaster's Canadian Housing Evidence Collaborative has provided to our housing programs throughout the years.

This letter is provided to express my support for the creation of a Master of Public Policy (MPP) degree stream focused on housing policy at McMaster University. Housing is a central component of society. Its availability, affordability and sustainability have deep implications for the social and economic organization of communities. The need to understand housing policy is enduring, as the present housing crisis underscores the continued need for engagement on housing.

Housing, Infrastructure and Communities Canada has been responsible for providing housing policy advice to the federal government for a little over one year. In that short time, I have come to know the complexity of this policy space, which requires deep interdisciplinary knowledge of city planning, land use policy, the housing construction industry and more. Housing policy merits academic focus and rigour in its own right.

To date, I understand that no Canadian university has a dedicated degree stream educating students on housing policy. Only individual courses, often not permanently offered, exist in schools of public policy on the topic. Canada lags behind many of its G7 peers in that regard. Elite universities such as the Harvard Graduate School of Design, the Weitzman School of Design at the University of Pennsylvania and the University of Glasgow all have graduate programs dedicated to housing policy. Now, more than ever, young professionals are needed to undertake comprehensive research and support robust policy analysis on housing issues from an interdisciplinary and distinctly Canadian perspective.

The Department would like to cease offering the “stream in social psychology.” The current coursework option, the major research paper option and the thesis option would not be affected by this request. The department research areas and PhD comprehensive area remain unaffected by this decision.

Reasons for the Motion

Faculty Complement

- There are several courses we have to offer on an annual basis to meet the requirements of the stream. Our faculty complement has changed since 2015 when the stream was created. Five of the original faculty have retired.
- Three of the current five faculty are cross-appointed limiting availability for graduate teaching in the stream.
- The need to cover required graduate and undergraduate methods and theory courses also limits availability to teach courses dedicated to the stream.
- Faculty currently offering courses for the stream may wish to teach courses beyond these requirements.

Student Comments & Experiences

- The Social Psychology Stream was originally introduced to increase interest amongst potential MA students. There is no evidence that this has been effective.

- Many students have reported that they feel misled about what the stream offers and what it provides. This is particularly true for the students coming from the FSS Social Psychology program.
- Students in the IQAP focus group reported that they wanted to see more variety in offerings related to Social Psychology and that the stream seemed to be very anchored in Sociology with some Social Psychology included but not enough to be considered a separate stream.
- Student choice of the stream vs coursework option (in program) seems to be based on the course selection available rather than interest¹.
- The Social Psychology Stream has not been acknowledged on the degree parchment since 2021. MA alumni have expressed dissatisfaction with this lack. On the transcript the stream is shown as “Sociology – Social Psychology – MA (course based)” vs “Sociology – MA (Course based).”

1. Our information is based on informal polls conducted by the Graduate Student Caucus, and reports by Graduate Committee Student Representatives over the past three years.

Rationale for the Recommended Change (How does the requirement fit into the department’s program and/or tie to existing Program Learning Outcomes from the program’s IQAP cyclical review?):

The stream was reviewed during the 2022-23 IQAP. Reviewers recognized that the stream is a mismatch as it is not interdisciplinary like the B.A. program in Social Psychology. It also was pointed out that the stream is understaffed despite student interest and that it should either be strengthened or eliminated. As available faculty complement is limited, elimination is logical outcome. Again, faculty in this research area are either cross appointed or are needed to teach vital graduate methods courses.

Three members of the Committee constitute a quorum.

2. The Secretary of the Committee shall be the Senior Associate Registrar and Graduate Secretary, or their delegate.

3. Members will be appointed for a two-year term. Students are appointed for a two-year term or until graduation or withdrawal from the University, whichever occurs sooner. The membership of the Committee will be appointed by the Vice-Provost and Dean of Graduate Studies in consultation with Associate Deans (Graduate Studies) from the Faculties. The Vice-Provost will ensure that all Faculties have representation on the Committee over a four-year period.

4. The powers and duties of the Committee are as follows:

- produce an annual report on aggregated financial support data from McMaster, in partnership with the Office of Institutional Research & Analysis, for Graduate Council. After consideration by Graduate Council, the data will be presented publicly in a dashboard format.
- consider questions arising from issues of financial support for graduate students at McMaster. Collective agreements are not within the scope of the committee's remit. When deemed appropriate, the Committee may make recommendations to Graduate Council.
